# 8 PARKING CONTROL AMENDMENT TOWNSHIP OF KING

### 1. **RECOMMENDATIONS**

It is recommended that:

- 1. Eleven parking control bylaws on the Regional road network in the Township of King be amended as per *Attachment 1*.
- 2. The Regional Solicitor amend the necessary bylaws to effect the proposed changes.
- 3. The Regional Clerk circulate this report to the Township of King and to the Chief of York Regional Police.

#### 2. PURPOSE

The purpose of this report is to amend 11 parking control bylaws on the Regional road network in the Township of King.

# 3. BACKGROUND

# The Township of King has identified key initiatives to improve economic viability of King's community core areas

On November 14, 2011, the Township of King Council initiated their Integrated Community Sustainability Plan to support the significance and importance of creating "walkable" communities for residents and businesses. In addition, the Township of King Council is in support of opportunities to enhance the community cores of Nobleton and King City by permitting on-street parking near key intersections and business areas.

The Transportation Services Committee received a letter from the Township of King on November 30, 2011 requesting on investigation and report on options for permitting onstreet parking during off peak hours at the following locations:

- Nobleton, in the vicinity of King Road and Highway 27
- King City, on King Road east of Keele Street to Banner Lane

This report is in response to these two requests.

### 4. ANALYSIS AND OPTIONS

# The Township of King requested staff to investigate and permit on-street parking during off peak hours in the community of Nobleton and King City

Regional staff reviewed the existing parking control bylaws and conducted a sign inventory in Nobleton and King City. There are currently eight No Parking and three No Stopping bylaws in place on these road sections. Tables 1 and 2 summarize the proposed parking control revisions in Nobleton and King City, respectively.

On-street parking is a key factor in supporting businesses in central business districts adjacent to Regional roads. As a type of shared parking, on-street parking is an efficient means for allowing multiple users to reach multiple destinations. On-street parking utilizes less land per space than off-street parking and provides easy access to businesses located on Regional roads. For pedestrians, on-street parking creates a buffer between moving traffic and individuals walking on the sidewalks, providing a measure of safety and reducing the level of perceived noise. Further, depending upon how on-street parking is situated on a street, it can also serve as a traffic calming measure, slowing vehicles and potentially reducing the frequency and severity of collisions.

On-street parking however can increase congestion on certain roadways. It essentially 'closes' the curb lane for use by through traffic. Where peak hour parking restrictions are in place even a single illegally parked vehicle can have a severe impact on orderly traffic operations.

Based on staff review, no parking control changes are recommended on Highway 27 between 75 metres south of Sheardown Road to 225 metres north of Sheardown Road due to the amount of heavy trucks that park or stop on the right shoulder lane to access a coffee shop located on the northeast corner of the intersection. In addition, this creates a visual obstruction for on-coming traffic and increases traffic congestion for this two-lane urban road section. Therefore, staff do not recommend revising the No Parking bylaw for this road section in Nobleton.

Staff recommend that parking and stopping be permitted outside the critical morning (7:00 a.m. to 9:00 a.m.) and evening (3:00 p.m. to 6:00 p.m.) peak hours when traffic volumes are substantially less. Providing motorists with the opportunities to park and stop will benefit the business communities of Nobleton and King City. Therefore, No Parking and No Stopping bylaws should be revised to permit on-street parking and to prohibit parking and stopping from 7:00 a.m. to 9:00 a.m. and from 3:00 p.m. to 6:00 p.m. Monday to Friday in Nobleton and King City, as listed in *Attachment 1* and *Attachment 2* shows the location map.

#### Link to Key Council-approved Plans

Vision 2026 — promoting safety on York Region roads through effective policing, education and sensitive design.

#### 5. FINANCIAL IMPLICATIONS

The costs associated with staff review time and the removal of signs are included within the 2012 Transportation and Community Planning Budget.

The Provincial Court of Justice approves the parking set fines for York Region in order to enforce the parking control bylaws. York Region comprises of nine municipalities that designate their own parking set fines that vary from each municipality from \$25 to \$100.

# 6. LOCAL MUNICIPAL IMPACT

The recommended no parking and no stopping revisions relate to the Regional road system. Township of King staff has been advised of the proposed parking control changes within this report and indicated their support.

# 7. CONCLUSION

Regional staff initiated a review of the existing No Parking and No Stopping bylaws in Nobleton and King City.

Staff recommends the parking control bylaws should be revised to permit on-street parking and to prohibit parking and stopping from 7:00 a.m. to 9:00 a.m. and from 3:00 p.m. to 6:00 p.m. Monday to Friday in Nobleton and King City.

This will promote community living in built up areas, where motorists will be permitted to park and access local businesses. In addition, this will reduce the number of signs thereby reducing sign clutter and sign maintenance activities. However, the road section of Highway 27 do not recommend revision as it will create visual obstruction and increase traffic congestion in Nobleton.

The Regional Solicitor should prepare the necessary bylaws and the Regional Clerk should circulate a copy to Township of King and to the Chief of York Regional Police.


